Furthermore, I agree, on behalf of myself, my heirs, executors, administrators, successors and/or assigns, to indemnify and hold harmless the Releasees from and against any and all Claims made by any third party arising out of my participation in the Festival. Such obligation shall not be construed to negate, abridge, or reduce other rights or obligations of indemnity which would otherwise exist as to any party or person described in this Release and Indemnity Agreement.

I agree to keep confidential and not to disclose any non-public information, regarding the Program or any of the Releasees, disclosed to me during the course of my participation as a volunteer relating to the Festival.

I give and grant to Kitty Hawk Kites and its officers, employees, agents, representatives, affiliates, subsidiaries, consultants, independent contractors, successors, assigns, designees and licensees ("KHK"), the right to use and publish my name, nickname, voice, picture, portrait, likeness, characteristics, live or recorded performance, photograph, signature or facsimile thereof, and biographical materials (the "Identity") as embodied in materials associated with KHK's marketing, advertising, sales or promotional efforts (the "Materials") in all forms of media now known or hereafter created, including without limitation, video, television, print, billboards, point-of-purchase materials, corporate communications, internal and external marketing pieces, and Internet in any and all territories throughout the world.

In the event that any clause, term, or provision of this agreement shall be deemed or adjudicated void or invalid, it shall in no manner affect the validity or enforceability of the remaining clauses, terms, and provisions herein which shall remain in full force and effect.
